# **Release and Waiver of Liability**

PARTICIPANT UNDERSTANDS THAT THIS RELEASE DISCHARGES CASPA FROM ANY LIABILITY OR CLAIM THAT THE PARTICIPANT MAY HAVE AGAINST CASPA WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM PARTICIPANTS ACTIVITIES WITH CASPA, WHETHER CAUSED BY THE NEGLIGENCE OF CASPA OR ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS OR OTHERWISE. PARTICIPANT ALSO UNDERSTANDS THAT CASPA DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.

# 2. Medical Treatment.
